Overview of Qatar Health 2021



Qatar Health 2021 will offer a 3-day program, with 3+1 multi-disciplinary tracks, preceded by 1 day of preconference workshops and symposia. The tracks will be as follows: Pandemic Mitigation and Control [PMC], Post-Pandemic Preparations for Mass Gatherings [PPMG], Post-Pandemic Trauma Systems [PPTS] plus Post-Pandemic Research [PPR]. The tracks shall have a mix of direct lectures, panel discussions and Pro-Con debates and interaction with the participants will be strongly encouraged. Experts from the national, regional and international health sector, the World Health Organization and other international organizations involved in mass gatherings as well as sports organizations, academic institutions, healthcare leaders, disaster response managers, global experts and government bodies, will be sharing best practice and lessons learned. Delegates will be able to share experiences, learnings and best practice as well as advances in mass gathering preparedness and planning as we prepare for the FIFA World Cup in Qatar in 2022.

Track 1: Pandemic Mitigation and Control [PMC]

This track will focus on the best practice and lessons learned from experts in pandemic mitigation and control, from Qatar and worldwide. Invited speakers will share their experience and best practice in health communication, lockdown, mass testing, contact tracing, vaccine development and responses for manpower, infrastructure, mental health and ICU management.

Track 2: Post-Pandemic Preparations for Mass Gatherings [PPMG]

This track will focus on the best practice and lessons learned from experts in planning, organizing and conducting post-pandemic sporting and mass gathering events, from Qatar and worldwide. Invited speakers will share their experience and best practice as they resumed sporting and mass gatherings in the various disciplines of Football, Basketball, Baseball, Cycling, Tennis, Formula 1 Racing, Golf, the Olympics and others.

Track 3: Post-Pandemic Trauma Systems [PPTS]

This track will focus on the best practice and lessons learned from experts in pandemic trauma and emergency care, from Qatar and worldwide. Invited speakers will share their experience and best practice in post-pandemic trauma care in the pre-hospital setting, in the operating room, in the ICU, by type of injury, for mass casualties and for trauma research and injury prevention.

Track 4: Post-Pandemic Research [PPR]

This track will focus presenting local and international pandemic-related research as it relates to the 3 tracks. Ample time will be provided for both poster and oral virtual abstract presentations.

Aspetar will deliver a Sports Medicine in Mass Gatherings session. This 2-hour session will deliver state-of-the-art lectures from Aspetar expert faculty, with a long experience in planning, organizing and providing medical support at FIFA events, major football leagues, and the IAAF. Aspetar will also share best practice for preparing individual athletes to return to competition performance levels after prolonged inactivity or illness.

Conference Objectives

- 1. To provide the participants with updates on the latest developments, recent evidence and best practice in the fields of disaster medicine, infectious disease and trauma surgery in the context of mass gatherings
- 2. To provide the participants with knowledge on the latest developments, recent evidence and best practice in the fields of disaster medicine, infectious disease, trauma surgery in the context of pandemic mitigation
- 3. To provide the participants with professional education activities to enhance their knowledge on the latest initiatives and programs from NHS-MoPH, SCDL and other stakeholders in local healthcare and FIFA2022
- 4. To recognize, celebrate and showcase the front liners, success and lessons learned from the national COVID-19 response of Qatar



About the Conference

Key Speakers

Invitation to international speakers is already ongoing. We are expecting a total of 32 speakers all attending via online platforms. A total of 60 speakers will come from local.

Target Audience

Based on the participant profile from Qatar Health 2020, we can expect at least 3,000 participants to a maximum of 5,000 attendees. The majority will be nurses, followed by physicians and allied health medical professionals (EMTs, pharmacists, respiratory, occupational and physical therapists.)

Scientific Program

Qatar Health 2021 will offer a 3-day program with four (4) multi-disciplinary tracks, preceded by a one day of pre-conference workshops and symposia. The tracks shall have a mix of direct lectures, panel discussions and Pro-Con debates and interactions with the participants.

Posters and Exhibitions

There will be ample opportunities for virtual presentations of submitted abstracts. A conservative estimate is set at 20–30 per track, with at least 70% from local researchers.

For partners, sponsors and exhibitors, we will strictly follow the HMC Medical Education and QCHP regulations on sponsorship.

The event will also feature a 2-hour opening ceremony that will also be delivered on a virtual platform.

The conference will feature a main lecture hall, breakout sessions, exhibition hall, poster displays and presentations, meet the experts space and a VIP meeting space. The language of the conference will be English.



Terms of Agreement
