To strengthen the person-centered care culture and encourage active participation from our service users, the training is co-designed and co-delivered with patients and family members. The focus of the training is on effective communication and mutual compassion to improve the quality of treatment and results for both patients and family members as well as nurses.

#### On October 23, 2023, the Arabic CHI took place in the Crowne Plaza Hotel.

Eighteen patients' families and care partners attended, expressing their excitement and appreciation for the opportunity to participate in many experience activities. They enthusiastically participated in every activity and suggested that other PFAs take this course.


